#### 020 Mend the Line Mental Health

For this training, First Responders will be defined as Police Officers, Firefighters, Dispatchers, and Emergency Medical Services; both EMTs and Paramedics. In this course, participants will learn barriers to first responders seeking mental health care services, treatment considerations, common problems first responders face, and additional resources that are available to members of this population.

**Course Objectives:** 

Participants will be able to:

- Name at least 4 barriers to First Responders seeking mental health treatment.
- Identify at least 5 areas of concern that First Responders face.
- Name at least 2 treatment modalities for treating First Responders.
- Gain a better understanding of suicidality in First Responders.
- Learn resources that are available to First Responders.

#### 030 Traffic Incident Management

Better incident response improves the safety of responders and drivers, reduces crashes that occur because of incident-related congestion, decreases traffic delays caused by incidents, and can cut incident response time. The National Traffic Incident Management Responder Training was created by responders for responders. This course provides first responders a shared understanding of the requirements for safe, quick clearance of traffic incident scenes; prompt, reliable and open communication; and motorist and responder safeguards. First responders learn how to operate more efficiently and collectively.

040 Structural Collapse Awareness	Q0002

This course will cover aspects of safety that should be considered when operating on the scene of a building collapse. The goal of this course is to give responders an overview of how to operate on the scene of a structural collapse when assisting other responders. Topics to be included: Building Construction/sub standardized construction, vehicle accidents into a structure, weather related structural collapse, terrorism acts of structural collapse, scene security and personnel accountability.

#### 050 CPR/AED

In this course, students will learn how to recognize a life-threatening emergency, how to provide basic life support, the proper use of an AED and what to do in case of an airway obstruction or choking.

#### 060 Basic Firefighting I

This course will cover four of the recommended twenty hours of training for new firefighters and enhance the knowledge of the veteran firefighter. It will consist of one hour of Personal Protective Equipment and three hours of Fire Behavior.

#### Equipment needed: Full turnout gear, including SCBA.

#### 00000 rant Writing 101

Budget constraints are tough on many Fire Departments in today's society. In this course, students will learn about and discuss the different Grant avenues that are available for your agency. The instructor will also discuss key points that will help increase the chance of your grant being successful.

#### 080 Vehicle Extrication (HANDS-ON)

Q0001

This course is designed to educate the rescuer on the proper techniques of vehicle extrication. Topics covered will include safety, scene size-up & preparation, stabilization, as well as various types of patient extrication techniques. This will be a strictly hands-on course where students will learn and practice the most up-to-date techniques for patient disentanglement, dashboard displacement, incident management & scene safety.

Equipment Needed: Helmet, eye protection, extrication jumpsuit or turnout gear, gloves & boots.

#### 100 EMT Con-Ed III

Topics covered on this day will include 4 hours of Medical, 2 hours of Airway, and 1 hour each of OB/GYN & Pediatrics.

#### 105 Basic Firefighting II

Various

This course will cover eight of the recommended twenty hours of training for new firefighters and enhance the knowledge of the veteran firefighter. It will consist of 2 hours of Personal Protective Equipment, 3 hours of Forcible Entry and 3 hours of Ladders.

Equipment Needed: Full turnout gear, including SCBA.

#### **110 Elevator Emergencies**

This course will cover the construction and design of elevators and elevator shafts, safety mechanisms, access, as well elevator emergencies and victim rescue. This will consist of classroom presentation, as well as hands on scenario practice.

Equipment Needed: Helmet, eye protection, extrication jumpsuit or turnout gear, gloves & boots.

115 Solar Panels & Hybrid Vehicles	B0000

This course will be (4) hrs. of training in Solar Panel Awareness & (4) hrs. of training in Hybrid Vehicle Technology.

Solar Panels are becoming increasingly popular in residential and commercial occupancies. Firefighters must understand the multiple hazards that exist with solar panels and the various ways they are constructed and installed.

Hybrid Vehicles travel roadways in every jurisdiction daily. These vehicles are often hard to identify and even harder to mitigate. This course will provide responders with the information needed to properly identify a hybrid vehicle by visual indicators, provide an understanding of hybrid vehicle systems and hazards, and describes proper response procedures that ensure the safety of emergency personnel.

#### 120 Let's Fight Fire I- LIVE FIRE-Structural Firefighting M0001

This course is for the new, or even experienced firefighter, who wishes to learn more about the tactics of structural firefighting. Instructors will cover aspects of hose handling, hose advancement, suppression, ventilation, fire behavior and fire control. This class will utilize training props that involve live fire training evolutions.

Equipment Needed: Full turnout gear and SCBA and spare cylinder. All turnout gear must be NFPA compliant with no component older than 10 years. Students will not be allowed to participate if the instructor(s) find that the gear is not NFPA compliant or otherwise poses a significant hazard.

Prerequisite: Completion of NFPA 1403 required components prior to enrolling; Live Fire Course Competency Form is required. OSHA 1910.134 (No Facial Hair impeding the seal of the facepiece)

#### 125 Smoke Reading (Fire Behavior)

Today's structure fires are more dangerous than ever before. Lightweight construction, low-mass synthetics, and open space floorplans have created a perfect storm for rapid, prolific fire growth and extreme behavior. It is imperative for firefighters of all ranks and experience levels to be prepared for this new battle. Smoke Reading provides the knowledge necessary for first-arriving firefighters, officers, and chief officers to determine the fire's location, progression, and future "from the seat" before seeing any flame. This knowledge ensures that the correct tactics are implemented for the best possible outcome.

This course will include classroom and visual aids that will be conducted outside. No protective equipment will be required.

#### 130 Fire Inspector II-KY. Fire Marshall

This class is the second step in the Fire Marshal's revised Fire Inspector program. This class is designed for fire inspectors and building code officials that deal with life safety issues on a daily basis. The students will get detailed instruction on specific occupancy requirements, occupant load calculations and seating arrangements. This class will consist of instruction followed by an exam. Certificates are issued upon passing the test. Course Objective: Attendees will be instructed in the performance of and requirements for complex fire inspections and code recognition. Gain knowledge in occupant load calculation and seating arrangement in places of assembly, fair and exposition centers, and special events.

#### Equipment Needed: None

Prerequisites: Fire Inspector I, verified by a copy of your Inspector I certificate and 6 months in the performance of inspections verified by your Chief or Supervisor.

This is a 1-day course offering 8 HRS for Continuing education of Fire Safety and Building Code Certification

#### 135 Drivers Training

This course will include classroom presentation, as well as hands-on practice with a Driver Training Simulator and Cone Course. Topics such as safe operation of a fire apparatus, laws regulating operations, and frequent causes of accidents will be discussed. This course has been updated to include additional information and skills on inspection of apparatus.

#### 140 EMT-Con Ed IV

Topics covered on this day will include 3 hours of Patient Assessment, 4 hours of Trauma, and 1 hour of an elective.

#### 145 Basic Firefighting III

This course will cover eight of the recommended twenty hours of training for new firefighters and enhance the knowledge of the veteran firefighter. It will consist of 2 hours of Safety, 3 hours of Fire Hose Nozzles & Appliances and 3 hours of Loss Control (Salvage & Overhaul).

Equipment Needed: Full turnout gear, including SCBA.

#### 150 Farm Rescue

This course will consist of Farm Rescue and will demonstrate tractor rollovers and farm machinery rescue of victims under lawn mowers and utility vehicles. This will consist of mostly hands-on training that allows the students to partake in scenarios of various rescue evolutions related to farming incidents.

Equipment Needed: Helmet, eye protection, extrication jumpsuit or turnout gear, gloves & boots.

#### **155 Fire Alarms & Suppression Systems**

This class is developed and presented for the industry professionals that are required to attend and receive recertification credit for licensure. It will help students have a deeper understanding of fire alarm systems. Class will have discussions as to where alarms are required, installed and maintained. Also, proper inspection of the systems, how they function, how they help save lives, and how they may benefit the fire service. This class will be classroom, as well as hands-on training with a fire alarm panel and suppression systems.

#### LIVE Fire-Flammable and Combustible Liquids

Flammable and combustible liquid incidents are a very common types of hazardousmaterial incidents to which fire departments respond. These liquids, present in almost every home and workplace, are particularly hazardous due to their ability to produce vapors and can ignite easily, burn with extreme rapidity, emit a large amount of heat and often produce clouds of thick, black, toxic smoke. Preparation and proper training are essential for firefighters handling incidents involving flammable liquids and gases.

Participants in this course will learn backgrounds of flammable liquids and gases, storage and transport of these products, and how to safely respond to propane emergencies frequently encountered by emergency personnel.

# Equipment Needed: Full turnout gear and SCBA and spare cylinder. All turnout gear must be NFPA compliant with no component older than 10 years. Students will not be allowed to participate if the instructor(s) find that the gear is not NFPA compliant or otherwise poses a significant hazard.

Prerequisite: Completion of NFPA 1403 required components prior to enrolling; Live Fire Course Competency Form is required. OSHA 1910.134 (No Facial Hair impeding the seal of the facepiece)

#### 165 Fire Inspector I-KY. Fire Marshall

DD0000

This class is the first step in the Fire Marshal's revised Fire Inspector program. Fire and building code officials will benefit from this course. This class will provide instruction based on NFPA 1, 2018 Fire Code, NFPA 101, 2018 Life Safety Code, the Kentucky Standards of Safety (815 KAR 10:060) and the Kentucky Building Code. Officials will learn basic principles of fire inspections, and how it relates to the KBC and IBC. This class will consist of one fast paced day of instruction followed by an exam. Certificates are issued upon passing the test.

Course Objective: Prepare the attendees to conduct fire inspections of buildings for fire hazards and code compliance per 815 KAR 10:060 (The Kentucky Standards of Safety). Determine if fire protection equipment is operational, maintained and in compliance. Determine the adequacy of exits. Determine an occupant load for a facility. Where required, emergency fire evacuation drills are held. Advise property owners of the inspector's findings. Gain an understanding of projects that must be approved by the Division of Building Code Enforcement and other Divisions within the Department of Housing, Building and Construction.

Equipment Needed: None

Prerequisites: None

This is a 1-day course offering 8 HRS for Continuing education of Fire Safety and Building Code Certification.

#### 170 Mental Health First Aid

Mental Health First Aid (MHFA)for Fire/EMS teaches you the relevance of mental health to the Fire/EMS community. This class will provide information on the risk factors and protective factors specific to the Fire/EMS Community. The class will cover how to apply the MHFA Action Plan (ALGEE) in scenarios designed specifically for Fire/EMS professionals, along with national, regional, and community mental health resources for Fire/EMS professionals. It focuses on the unique experience and needs of Firefighters/EMS personnel and is a valuable resource that can make a difference in their lives, their coworkers' and families' lives, and the communities they serve.

#### 200 Ladder Trucks 101

#### HH0000

This course will include Ladder Truck Placement & Stabilization, Vent-Enter-Search, Victim Rescue, as well as Technical Rescue Evolutions with the use of a ladder truck. This will be a hands-on course with multiple instructors. There will be teaching aspects for truck drivers/operators, firefighters with the responsibility to make entry into house fires, as well as firefighters who have the responsibility to assist in rescue evolutions and ladder placement outside of the structure. This course will incorporate fire training towers where practice will be conducted on ladder placement, personnel entry/exit, as well as rescue scenarios. This course is a good option for personnel with little or no experience on a ladder truck, or for experienced personnel who aim to polish their skills.

Equipment Needed: Structural Firefighting Gear, SCBA.

Minimal Equipment Required: Helmet, Gloves, Eye Protection, Steel Toe Boots.

#### 210 Leadership & Supervision: Creating Environments for Professional Growth AA0000

This 2-day course presents the supervisor with the basic leadership skills and tools needed to perform effectively in the fire and Emergency Medical Services environment. Topics covered include: concepts related to a successful transition to supervisory and leadership roles, concepts of adaptive leadership, change management, active followership, effective communication (including difficult conversations and advocacy-inquiry based dialogue), ethics, authority, power, decision-making and active engagement through development of a personal plan.

This course was developed by the National Fire Academy.

Prerequisites: ICS-100 & ICS-200

#### 220 Tactical Emergency Medical Care

The 2nd edition of NAEMT's Tactical Emergency Casualty Care (TECC) course teaches EMS practitioners and other prehospital providers how to respond to and care for patients in a civilian tactical environment. This 2-day course presents the three phases of tactical care and integrates parallel EMS nomenclature including Hot Zone/Direct Threat Care that is rendered while under attack or in adverse conditions, Warm Zone/Indirect Threat Care that is rendered while the threat has been suppressed but may resurface at any point and Cold Zone/Evacuation Care that is rendered while the casualty is being evacuated from the incident site. Patient simulations are incorporated into the course and will cover the following topics: • Hemorrhage control including immediate action drills for tourniquet application throughout the course; • Complete coverage of the MARCH assessment; • Surgical airway control and needle decompression; • Strategies for treating wounded responders in threatening environments; • Caring for pediatric patients; • Techniques for dragging and carrying victims to safety; and • A final, mass-casualty/active shooter event simulation

#### 230 Arson I – Fire Investigations for First Responders

This is the National Fire Academy course, "Fire Investigations for Fire Responders" (2022). The purpose of this 2-day course is to provide first responders with the tools to understand the key role they play in fire scene examination and in preserving and protecting important evidence for any subsequent investigation. The content of the course will provide a clear definition of the role of the first responder and identify the preservation and protection of evidence and proper reporting of the information to appropriate officials.

*Prerequisites:* All class participants will need to obtain a FEMA Student Identification (SID) number and provide it on the first day of class.

In consideration of the Kentucky Community and Technical College System ("KCTCS") Kentucky Fire Commission

State Fire Rescue Training (referred to hereafter as "SFRT") allowing me to participate in this emergency service training class, I represent and agree as follows:

1. Assumption of Risk. I understand and acknowledge that the very nature of the training is dangerous and there are certain inherent risks associated with participating in the training, including but not limited to firerelated risks. I understand that the specific risks vary, but that they include injury, loss, or damage to myself or my property, or death, resulting from exposure to fire and unsafe conditions. I understand that efforts will be made by the instructional staff to create a working environment that is as safe as possible, and that the instructional staff will give me careful and prudent instruction in the operation of equipment and how to perform each task. However, I also understand that neither KCTCS nor SFRT – nor their respective boards, officers, agents, or employees – has control over these inherent risks, and that the risks cannot be eliminated completely regardless of the care taken by KCTCS or SFRT. By signing below, I represent that I appreciate the risks. I accept and voluntarily assume all risks that may arise from or in connection with my participation in the training. I understand that I am ultimately responsible for my own safety, and for my actions at all times.

2. Participation. I agree to perform only those activities specifically designated for the training, to follow all instructions and directions given to me by the instructional staff, and to adhere to all applicable safety standards. I will not participate in any activity that is not directly related to the training and class function, and I will ask for additional information before I proceed with a training procedure if I am unsure of the procedure or of the instructions and directions given.

3. Workers' Compensation. I understand that in order to participate in this training, I must be a member in good standing with a fire department or response agency, and I must be covered by the workers' compensation insurance of that department or agency. ### Live Fire Course Competency Validation/Fitness for Duty Form

Required for all students before participating in SFRT Live Fire Training

NFPA 1403 (2018 Edition) 4.3.1 - 4.3.3 require that all participants must have prior training and meet prerequisites in certain subjects before participating in live fire training. These minimum subjects include:

1) Safety; 2) Fire Behavior; 3) Portable Extinguishers; 4) Personal Protective Equipment & SCBA; 5) Ladders; 6) Fire Hose, Appliances, and Streams; 7) Overhaul; 8) Water Supply; 9) Ventilation; 10) Forcible Entry; 11) Building Construction. Specific prerequisite training must also be met in these areas: Fire Dynamics; Health and Safety; Fundamentals of Fire Behavior; Fire Development in Compartments; Nozzle Techniques and Door Control.

NFPA 1403 (2018 Edition) 4.4.1 requires that all participants must be rehabbed in accordance with NFPA 1584, Chapter 6. Before being released from the rehab area to participate in a State Fire Rescue Training live fire training evolution, normal conditions are considered to consist of: heart rate of 60-100; respiratory rate of 12-20; systolic blood pressure less than 160; diastolic blood pressure of less than 100; pulse oximetry of 95% or greater. Participants are encouraged to periodically check their vital signs and seek appropriate medical attention for abnormal signs/symptoms.

Participants must be a member of a Fire Department, Industrial Fire Brigade or Junior Firefighter

program (Ages 15-17) that is recognized by the Kentucky Fire Commission to participate in live fire training delivered by State Fire Rescue Training. ID's will be checked by SFRT instructors before allowing students to participate in live fire training and some evolutions/activities are restricted for 15-17 year old Junior Firefighters (See current Junior Firefighter Guidelines on KY Fire Commission website.) All turnout gear must be less than 10 years of age. Per NFPA 1403 (2018 Edition) A4.9.5 it is recommended that all participants wear full-length clothing made of natural fibers or fire-retardant materials under their personal protective equipment during live fire evolutions.

Facepiece seal protection: SFRT requires that all students must be compliant with OSHA 29 CFR 1910.134: "[910.134(g)(1)(i) - The employer shall not permit respirators with tight-fitting facepieces to be worn by employees who have: 1910.134(g)(1)(i)(A) - Facial hair that comes between the sealing surface of the facepiece and the face or that interferes with valve function;" (hair growth between the skin and the facepiece sealing surface, such as stubble beard growth, beard, mustache or sideburns which cross the respirator sealing surface).


